OFFICIAL RULES

SBI 10 Years Anniversary Lucky Draw (the "**Promotion**") is sponsored by SBI Remit Co. Ltd, having its address at Izumi Garden Tower 13F, 1-6-1, Roppongi Minato-ku Tokyo, 106-3013 (the "**Sponsor**").

1.1 Officers, directors, employees, independent contractors, interns and agents and other representatives of the Sponsor and its parent company, subsidiaries, and affiliates and its retail agents, advertising agencies and any other company or individual involved with the design, production, execution or distribution of the Promotion, including but not limited to, their family members and relatives up to the second degree of consanguinity, affinity and individuals living in the same households of each of these individuals (collectively, together with the Sponsor, the "**Promotion Entities**") are ineligible to participate in the Promotion or win prizes.

2. Eligibility and Entry

- 2.1 The Promotion is open to all legal residents and citizens of Japan who are eighteen (18) years or older ("Participants").
- 2.2 The Promotion period is from April 1, 2021 to March 31, 2022 ("Promotion Period").
- 2.3 To enter the draw, a Participant must conduct a MoneyGram send transaction through the Sponsor, as a member of the Sponsor, during the Promotion Period (no minimum amount is required for the transaction) (a "Qualifying Transaction").
- 2.4 Each Participant will receive one (1) entry into the draw for a Qualifying Transaction.

3. Winner Selection and Notification.

- 3.1 There will be twelve (12) draws during the Promotion Period, with each draw conducted within two (2) weeks at the end of each month within the Promotion Period.
- 3.2 There will be ten (10) winners for each draw, with a total of one hundred and twenty (120) winners ("Winners") for the entire Promotion.
- 3.3 Each Winner will win a cash prize of ten thousand yen (JP¥10,000). The Sponsor will deposit the cash prize directly into the bank account of each Winner.
- 3.4 The Winners will be randomly selected from the entries.
- 3.5 The Sponsor will notify Winners.
- 3.6 The prizes are not transferable. Winners are responsible for tax liability where applicable.
- 3.7 To claim the prize, Winners must present at least one (1) valid ID and proof of the relevant Qualifying Transaction.
- 3.8 If any Winner is subsequently found not eligible to participate in this Promotion, the Sponsor may at its sole discretion forfeit or reclaim the prize and award or dispose of the same in such manner and to such person as it deems fit.

4. GENERAL RULES
