

SBI Remit Welcome Home Kabayan 2018

OFFICIAL RULES

- 1.1 SBI Remit Welcome Home, Kabayan Contest 2018 (the "Contest") is sponsored by SBI Remit, having its address at Izumi Garden Tower 13F, 1-6-1, Roppongi Minato-ku Tokyo, 106-6018 (the "Sponsor").
- 1.2 Officers, directors, employees, independent contractors, interns and agents and other representatives of the Sponsor and its parent, subsidiaries, and affiliates and its retail agents, advertising agencies and any other company or individual involved with the design, production, execution or distribution of the Contest, including but not limited to each of their family members and relatives up to the second degree of consanguinity, affinity and individuals living in the same households of each of these individuals (collectively, together with the Sponsor, the "Contest Entities") are ineligible to enter or win prizes.

2. Eligibility and Entry

- 2.1 The Contest is open to all *residents / citizens* of Japan who are eighteen (18) years or older ("Participants").
 - 2.1.1 The Contest period will be from 1st February, 2018, 09:00 HRS (Japan Time) to 30 April 2018, 23:59 HRS (Japan Time) ("Contest Period").
- 2.2 To enter the draw:
 - (i) Participants must conduct a MoneyGram send transaction at any of the SBI Remit locations ("Participating Locations") or via online remittance service provided by SBI Remit during the promotion period.

3. Winner Selection and Notification.

- 3.1 Two (2) winners will be randomly selected for the entire Promotion Period as follows:

- 3.2 The two (2) winners will be chosen via an electronic draw based on an assigned number to each of the Qualified entry.
- 3.3 The winners will each receive ("Prize"):
 - i. One return air ticket in economy class from Tokyo to Manila at an air carrier of the Promoter's choice.
 - ii. The prize does not include transportation from and to the winner's city, extra travel baggage and personal expense of any kind that is not expressly covered in the package
- 3.4 The Promoter will not be responsible for arranging travel insurance, medical insurance, any transport expenses other than the air ticket as specified above, any meal expenses, expenses of a personal nature, other travel related expenses or such other expenses which have not been specifically included in the terms and conditions will be borne by the winners.
- 3.5 The Promoter will not be responsible for the inability of any winner to utilize the prize, for any reason whatsoever, including but not limited to non-issuance of a visa.

- 3.6 The Promoter will not be responsible for claims of any nature whatsoever for any loss, illness, and bodily injury including death of any winner and/or its companion arising out of participation in this Promotion or utilization of the prizes offered.
- 3.7 No cash alternative to the Prize will be offered. The Prize is not transferable. The Sponsor reserves the right to substitute the Prize with another of equivalent value.
- 3.8 No further entries to the Contest will be permitted after the expiry of the Contest Period.
- 3.9 The prize should be collected by the winner within the period and at the location that will be informed to the winner when the announcement of winning is made. The transport and other related fees that will occur for the collection of the prize will be borne by the winner.
- 3.10 If any winner is subsequently found not legible to participate in this Promotion, the Promoter may at its sole discretion forfeit or reclaim the prize and award or dispose of the same in such manner and to such person as it deems fit.
- 3.11 The Promoter's decision in all matters to do with the Promotion is final and no correspondence will be entered into.

- 4.1 The Sponsor and its agents and affiliates accept no responsibility for loss, damage or claims caused by or resulting from the Contest or the use of the Prize.
- 4.2 Winner agree to grant permission to the Sponsor to use their name, state/country of residence and prize information for advertising and promotional purposes in connection with the Contest without additional compensation, except where otherwise prohibited by law.
- 4.3 Notwithstanding any contrary provision in any of Sponsor's privacy policies, Participants grant to the Sponsor, and it reserves, the right to use any and all information related to the Contest, including information provided by Participants in connection with the Contest, for marketing purposes or any other purpose, unless prohibited by law.
